9.3 Report Finance and Strategy group – Cllr A Brooks

A meeting of the Finance and Strategy Group was held on Monday 9th May and the following were discussed

- 1. The title of the Group which has been changed to include Audit due to the more rigorous Auditing requirements recently put in place. The Committee will review bank accounts, investments and Bank reconciliations on a quarterly basis.
- 2. Attendance of members at the Parish Council meetings, how that information should be published and how to differentiate between the acceptable reasons for absence. It is the intention that this information should be made public each year.
- 3. The White Rose Update
- 4. Planning Committee the need to have a more in depth meeting of the committee to discuss the more contentious planning applications.

Cllr A Brooks proposed the change of name of the Group to Finance, Strategy and Audit Group, seconded by Cllr J Harrison

9.4 Approve Updated Asset Register – The Chairman requested approval of the updated Asset Register but after discussion it was decided this required further update so will be an item on the next Agenda for approval

10 REVIEWS

10.1 Local projects – Cllr S Kay

10.1.1 Defibrillator – The Ward committee will pay towards a defibrillator. The British Heart Foundation will also contribute but only if it placed in an unlocked container which the Parish Council were unhappy about. It was therefore decided the Chairman will pursue other funding.

The coins for HM Queen 90th Birthday have been distributed at the school and a thankyou note received. It was agreed after discussion to approach other Nurseries in the village for distribution of further coins – the Chairman will pursue this.

The seat is now in place in the Cemetery. The dispute over the placement of a memorial has re-emerged and is being dealt with, with the help of our legal advisors.

The Chairman has spoken to COYC regarding the verges opposite Grimme and it is being progressed.

The condition of the Scout and Guide hut has been raised with B Prince and he will advise the situation in due course.

The last available allotment has now been let.

Cllr J Maggs is awaiting to hear the outcome of the application to the Ward Committee for the Typhoon in the Playpark

Manor Park Corner is progressing

In Bloom are applying for a Water Bowser with a rechargeable battery to assist volunteers manoeuvre it up and down Church Street as well as York Street.

Cllr J Brooks is allocated two additional bins as a COYC Councillor and asked the PC to consider what form these should take and where they should be placed. The Chairman has also spoken to a representative of the Housing Association who have asked for two new dog bins but the concern is who will empty them. Cllr |J Brookes to discuss with COYC.

10.2 PFA Update – Cllr J Farmer reported as follows:

Junior membership is doing well and on a Sunday morning there is cricket/football/squash and tennis coaching for all ages.
Police issues mentioned previously.
A leaflet is to be distributed in the next couple of weeks.
The vice chair is obtaining quotes for CCTV to cover all field and play area. First one is £8.5k.
The second one should be in shortly.
The accounts for the PFA and the Sports Club are with the auditors and no queries have been raised to date – a copy will be sent to the PC when they are available.

- 10.3 Web site Cllr L Turnbull reported that the four members of the group had met last week to look at options for a new website. Looked at 3 quotes and the middle range option is being pursued. When this has been scoped it will be brought back to the PC for approval
- 10.4 In-Bloom Cllr R Freer reported he had attended an enjoyable party at the school where the coins were handed out. Two more donations received for In Bloom. A large number of prizes have now been received for the Tombola to take place at the coffee morning on the 11th June.
- 10.5 Environment Cllr L Turnbull reported that Steve Ashby had received an email from a Parishioner reporting two people doing a survey of the ditch opposite the sports club. The PC is aware that the Landowner is still considering what to do with the land.

A Tree inspection of some areas of parish council land has taken place. Cllr L Turnbull has a copy of the report which will also be published on the COYC website.

Pollinator project proposal for the Millenium Garden has been completed and will work alongside In Bloom. There may be an area in the Cemetery that will part of the project so a contribution from the PC for this may be requested.

The Parish Council asked that the group expand on the Trees report to include the types of trees.

The Hassacar Nature reserve noticeboard has now been erected.

- 10.6 Cemetery Cllr S Kay reported that the seat is now in place. Nothing else to report
- 10.7 Playpark Cllr J Maggs reported on a serious graffiti incident at the Playpark. The police are aware. The Playpark is looking good and additional help is now being given by Steve Moore. A sign is being designed to display the do's and don'ts in the Playpark.
- 10.8 Transport Cllr J Maggs reported on Road signs on the A1079 which are hidden by overgrown trees and are badly positioned.
 A discussion took place on the issue of the village being a rat run and the need for evidence as to it being the case or is it just residents arriving and leaving.
