#### 13 REVIEWS

13.1 Local projects – Cllr S Kay reported as follows:

Telephone Box – Cllr A Dykes is to follow up and try find a buyer.

Hassaccar Lane – A meeting was held with Yorkshire Water. A quote of £19k has been obtained to complete the work. The owners of the various parts of Hassaccar Lane have been contacted to ask for contributions. We have received a negative response from two land owners. Waiting for response from third owner before the way forward is decided.

Allotments – work is ongoing on new fencing. Several of the plots are in a poor state. This will be monitored.

13.2 PFA Update – Cllr J Farmer sent the following report:

AGM Thursday 19th July. Currently insufficient trustees to form a committee. Possible leaflet drop to emphasise the importance of PFA to the village to retain the facilities.

- 13.3 Web site Cllr A Dykes reported there would be a meeting in June and that in the month of April the site had the most number of hits to date.
- 13.4 In-Bloom Cllr R Freer reported that a coffee morning had raised £514. Another £180 donated collected whilst walking the village.
- 13.5 Environment nothing new to report
- 13.6 Cemetery nothing new to report
- 13.7 Playpark Cllr J Maggs reported the park is being heavily used. A full inspection has been carried out and only a few small issues found.
- 13.8 Transport Cllr J Maggs reported on the age old problem of HGV's going through the village. Some of the road signs are being covered by trees and seem to be in the wrong place. Cllr J Brooks will advise the Highways team.
