A request was received to contribute funding for a Street Party for HM Queen 90th birthday celebrations but the PC decided it would set a precedent and could not therefore contribute but the Chairman has ordered 350 coins for the children of the village to Commemorate the event.

Report Finance and Strategy group – Cllr A Brooks reported that the F&S Group had met and discussed the new requirements of the External Audit, this was explained to the PC. The Risk assessment was also discussed and Cllr Brooks pressed the importance of keeping this up to date.

Cllr Brooks mentioned the increase in Planning Applications and the importance of considering these carefully. As there are only two members on the Planning Committee at the moment Cllr A Dykes was nominated to be on the Committee.

A discussion took place as to how the planning group would operate in future.

6 REVIEWS 6

6.1 Local projects – Cllr S Kay reported that the PC will hopefully be able to apply for a defibrillator in April, this will be funded from Ward Money with a contribution from the British Heart Foundation.

The Chairman met with managing director of Grimme regarding the verges. He has agreed the best solution is to put down some 'hard standing grass' and is prepared to contribute. Cllr S Kay has contacted COYC but has not heard back as yet.

Ward Grant will be requested for In Bloom, Manor Drive Corner and the Primary school.

6.2 PFA Update – Cllr J Farmer reported as follows

The year end accounts are being finalised and the financial situation is looking much better. The loan has been completely repaid in addition to some rent. It is important to remember that the Sports Club is the funding mechanism for the Sporting Sections. That was its aim from the beginning.

There is a Greens meeting on Thursday to agree the rents for next year and to discuss the Sections needs for 2016/17. There is a lot of work that goes into keeping the facilities to the high standard that is achieved and a lot of volunteers put in a lot of work to ensure that sport is provided for the village.

We have 3 quotes for the fire system and hope to review the squash roof and the possible installation of solar panels over the next year. The b-fit gym is looking to upgrade as demand has increased. We will be reviewing any possible sources of lottery/energy grants. The one downside is the vandalism and having put off getting CCTV cameras because the cost is so high there have been problems as follows and I do not think without CCTV we will either stop it or find the culprits. Glass on football pitch causing game to be cancelled.

- 1. Skateboarding on tennis courts and nets/handles tampered with.
- 2. Damage to football dugouts.
- 3. Laughing gas capsules found near tennis courts.
- 4. General Play area issues.

The cameras around the club seem to have stopped problems there so it does seem the only way forward.

- 6.3 Web site Cllr L Turnbull has obtained 3 different quotes for a new website. There will be a meeting between Cllrs S Kay, L Turnbull, A Dykes and the Clerk J Bone to discuss the quotes and websites available
- 6.4 In-Bloom Cllr R Freer reported that 1000 leaflets and flyers have been delivered, 28 cheques and some cash received in donations. A total of around £2,000 has been received. Flowers on The Green are in need of replacement and estimates have been obtained. A lady in the village has offered 25 packets of wild flower seeds.

- Allotment 3b has now been worked on by the Probation services and is now looking in a fit state to once again be let thanks have been given to the Probation service. The children at the school will be given their potatoes in a bucket this week.
- 6.5 Environment Cllr L Turnbull reported there will be an environment meeting on Wednesday 13th April. A successful pollinators workshop was held where 12 people turned up.
 - There will be an article by Steve Ashby in the next issue of Grapevine on the subject of Dunnington being a environmental friendly village.
- 6.6 Cemetery Cllr N Ford reported that the tree in the cemetery has now been moved and the groundworks for the seat have been dug. The new seat has been delivered and the gates and fences have been painted.
 - The outstanding memorial issue has now been resolved with help from YLCA.
- 6.7 Playpark Cllr J Maggs reported that the Ward committee grant application has almost been completed, quotes have been obtained and this will be submitted as soon as possible. Following the Annual Parish meeting two volunteers came forward one of which has begun providing help in the Playpark.
 - The Playpark has been used extensively over the school holiday period but there has not been as many problem issues. Litter still a problem but this is also a general issue in the village as the litter bins seem to be filling up quicker and no remedial action is being taken. Cllr J Brooks will follow this up with COYC.
- 6.8 Transport Cllr J Maggs reported the Transport issues need following up and this will be taken forward. A meeting will be arranged of the Transport group
 - 6.8.1 Traffic lights on Common Road Cllr J Errington reported that this was a key issue but the only way it would be taken seriously would be if a clear case was presented. A discussion took place where it was agreed that nothing will be done if work was not carried out to present a good case for traffic light installation. The costs would be excessive but it was agreed that this should still be pursued and a good case put forward. The Chairman will look at the last report that was compiled on this issue and will report back. More volunteers are needed to discuss the issue.
