- 11.3 Report Finance and Strategy group Cllr A Brooks reported that the F&S group had met to discuss the proposed Budget for 2018-19.
- 11.4 Budget 2018-19 The Chairman put forward a proposed Budget for 2018-19 to the Parish Council and this was discussed. A formal recommendation will be made at the January Meeting.

12 REVIEWS

- 12.1 Local projects Cllr S Kay reported on the following
 - Hassaccar Lane Discussions are still ongoing
 - LINKS Discussions are still ongoing to resolve issues
 - Allotments Rent to be increase from 2019 to £30 for a full plot £15 for a half plot. The increase will be advised in the 2018 rent agreement letters. A bond will also be requested from all new applicants of £50.

- Wheldrake Youth Club have requested a donation towards their activities. After discussion the Parish Council agreed they would not send a donation. The Clerk will write and advise.
- 12.2 PFA Update Cllr J Farmer reported as follows
 - Global4.com have been commissioned by COYC to do a survey to identify shortfalls in sporting facilities and to protect and enhance current facilities. The main issue is the lack of land for the current demand in football and cricket.
 - The Boxing Day Walk is for Parkinsons and Diabetes.
 - Two volunteers have been identified and Cllr Farmer will be meeting with them. They have a background of HR/risk assessment so should be able to assist the Sports Club and the PFA.
- 12.3 Web site Cllr A Dykes reported there are consistent patterns for visits to the website.
- 12.4 In-Bloom Cllr R Freer thanked those that had helped to install the Xmas Trees. A number of donations have been received for Xmas trees. A Xmas whist drive is to be held on Friday 15th December.

12.5 Environment – Cllr L Turnbull reported that the replacement trees have now been planted. Dunnington WI have donated £200 towards the trees. Dunnington in Bloom are contributing £100. A suggestion has been received to provide further protection for the trees on the green but the view of the Parish Council was that this was not necessary.

- 12.7 Playpark Cllr J Maggs reported that the ROSPA report had highlighted rot on the climbing frame. New parts have been ordered and these will be supplied free of charge as they were still in the warranty period. A potential new volunteer has met with John Maggs and they will meet again in the New Year.
- 12.8 Transport Cllr J Maggs reported that pot holes have been repaired and work has been done on dropped kerbs and driveways.
