#### 1 FORMALITIES

1.1 Apologies and reasons for non-attendance

Cllr J Farmer - Away

- 1.2 The PC approved the apologies from Cllr J Farmer. Cllr G Kay did not attend and apologies were received later the reason being due to work commitments.
- 1.3 Previous Meeting Minutes (9/1/17) The Minutes were approved and signed by the Chairman
- 1.4 There were no Declaration of Interests.

#### 2 POLICE REPORT

2.1 The PC discussed the new report layout which was thought to be more favourable. The proposed meeting with Inspector Lee Pointon is to be on the same date as the next PC meeting and a discussion took place as to how this can be addressed. The current fly tipping problems were discussed and it was decided that ClIr L Black will approach NYP for advice.

#### 3 PUBLIC PARTICIPATION

Rachel Jenkins attended and spoke to the PC in respect of a new project named LINKS which aims to deal with a new approach to isolation.

## 4 LINKS

The PC agreed to support this initiative and help with costs for leaflets and will investigate if this would be eligible for Ward Committee grants. They also agreed to offer Rachel Jenkins the opportunity to speak at the Annual Parish Meeting.

## 5 BANK ACCOUNT

5.1 The PC agreed that the Finance and Strategy Group should look at options for changing banking services.

## 6 **ANNUAL PARISH MEETING**

The Chairman is developing a flyer to go to every household in the Parish. Options for the Agenda were discussed.

### 7 BARRELS

A discussion took place in respect of future funding for replacement Barrels in the village and if the PC should continue to fund these. Sponsorship could be an option.

### 8 DUNNINGTON TRAFFIC ISSUES

A Community speed watch has now agreed and participant's names put forward.

The Common Road proposals were discussed – signs have been priced at £700 each by COYC (five would be required) – Cllr J Maggs will obtain the cost from COYC for the suggestion of bollards (four) opposite Grimme.

A discussion took place in respect of the moving of the 40mph zone inwards. This was not supported by the Parish Council. However it was agrred that a meeting was required with COYC to discuss the ongoing issues with speeding, Cllr J Maggs will arrange.

#### 9 SUPPORTING LOCAL BUSINESSES

Cllr A Dykes reported that four meetings have now taken place by the Local businesses and a meeting was taking place to form a business association. Everything was looking positive.

#### 10 TELEPHONE KIOSK

Cllr A Dykes is still awaiting for an update on costs to carry out the required work

#### 11 LITTER/DOG BINS

Cllr J Brooks has requested replacement bins but it is still not certain that there will be availability with funding.

The PC agreed that an article should be placed in Grapevine to stress that the Dog bags that the PC provides are for emergencies and should not be relied on as an automatic supply for all to use instead of buying them. The Chairman will write an article for Grapevine.

**14.3** Report Finance and Strategy group – Cllr A Brooks reported there had not been a meeting of the F&S group therefore nothing new to report

#### 15 REVIEWS

15.1 Local projects – Cllr S Kay reported that the enough support was received to approach the Ward Committee for funds to pay Yorkshire Water in respect of the Land at Hassacar. YLCA have been approached for advice in respect of the Terms of Reference. This is ongoing.

The CCTV at the Sports Club is being installed but no funds have been requested as yet. The refurbishment at the club is ongoing. No further news on the Youth Club awaiting Josette Farmer's return.

No further news on the MUGA at the school – Cllr J Errington will contact for an update

There is no new fencing at the allotment as yet.

- **15.2** PFA Update Cllr J Farmer was away but the Minutes had been circulated from the PFA meeting and things are going well financially.
- 15.3 Web site Cllr A Dykes reported that a meeting had taken place to discuss the progress of the website and various points will be sent to the website builder to work on. The Chairman has signed the End User Agreement to allow the PC to use the COYC (OS) maps.
- 15.4 In-Bloom Cllr R Freer reported there will be a coffee morning on 13<sup>th</sup> May 2017 to raise funds. It had been noticed that a stretch of York Road ditches had been cleaned but the debris had been thrown onto the spot where the daffodils grow.

Both Cllr Freer and S Kay reported on vehicles parking on grass verges in Church Lane and The Green and Cllr Kay has written to two Parishioners about this.

It was agreed that the PC were happy to pay for the cost of replanting the Route 66 bed from the 106 payments. The school gardening club will start in June.

In Bloom have agreed to clear the debris that has been dumped in Eastfield Lane.

- 15.5 Environment Cllr L Turnbull reported that a meeting had been held and the following agreed
  - A spec is being compiled to give to 3 contractors for the work on the trees which are the responsibility of the Parish Council.
  - There are to be 2 more pollinator beds in Millennium Gardens.
  - Friends of Hagg Wood have been planting more pollinators in the crater area
  - Dunnington Fayre will maintain and sponsor the small bed adjacent to the Activity Park.
  - The Spring clean will take place in early March.
  - A group meeting will take place again in March.

The Chairman has agreed that the PC will pay for trees which are the responsibility of the Parish Council to be lopped that are blocking the street lights.

- **15.6** Cemetery Cllr N Ford reported that a meeting had been held that day the following was discussed
  - Accounts looking good 16 plots have been purchased in this financial year.
  - Amendments have been done to the East side plan for access purposes.
  - The development of the next stage of the cemetery will be done a year in advance of it being required.
  - Agreed to purchase new signage
  - Agreed to cut the tall hedge bordering the north east side of the cemetery. This needs to be done before the end of February.
