4 <u>ALCOHOL BAN – PLAYPARK</u>

4.1 Discussion of Proposal to apply for an Alcohol Ban – Cllr J Maggs – Discussion took place as to the need for an alcohol ban in the play park. It was decided the PC would like to follow this through – Cllr J Maggs will investigate how this can be put into place.

5 ALLOTMENTS

5.1 Allotments Management Committee – after the visit by the Chairman, S Kay, Cllr R Freer and the Clerk J Bone to the allotments it was decided that it would be a good idea to form an allotment committee. Trevor Foreman has agreed to chair the committee. There are several allotment holders who are doing additional work to keep the allotments tidy.

It was noted that the sheep had escaped from the bottom field again. A letter will be sent to the owner of the field G Kay.

The Clerk was asked to follow up the request for 'No Dogs allowed' signs.

The issue of the stop cock at the Allotments was raised as nobody knows where it is. The clerk will follow up with Yorkshire Water.

5.2 Fence Maintenance – The maintenance of the internal fences within the allotments needs to be reviewed to ensure its robustness. The Clerk should ask the Management Committee if anything needs to be done immediately and ask them to consider a longer term maintenance plan.

6 **MATTHEW HILL PLOT**

Creation of Wild Flower Meadow – discussion took place as to the creation of a wild flower meadow on the Matthew Hill plot as it had become overgrown. Cllr J Farmer confirmed the grass has now been cut and it will continue to be cut over the summer. The Chairman thanked the PFA.

7 <u>ADOPTION OF STANDING ORDERS, FINANCIAL REGULATIONS, RISK</u> REGISTER AND ASSET REGISTER

The Chairman proposed the Standing Orders, Financial Regulations and Asset Register be adopted as they stand and dated as of 13th July 2015 – All agreed

It was agreed the Risk Register was also adopted but is an ongoing document and Cllr A Brooks said there would be some further detailed work done by the Finance and Strategy Group

8 MEMBERSHIP OF YLCA

Discussion on Proposal to join YLCA – A discussion took place as to the benefits which would help the Clerk, give the PC security that processes were correct and provide training for the Clerk and new Councillors, but it was also mentioned this could create more work for the Clerk. It was decided to subscribe for a year and review after that.

9 <u>LOCAL AND NEIGHBOURHOOD PLANS</u>

- 9.1 Update on the Local Plan Cllr J Brooks There are two main issues to be dealt with at the moment, firstly Demand which will determine the number of houses to be built and then when that is decided the locations will be chosen. Cllr Brooks said that the aim is to get on with the process as soon as possible. An update will be available when the Local Plan Group meet.
- 9.2 Update on the DPC Neighbourhood Plan Cllr D Martin As no new decisions had been made on the Local Plan by York City Council in relation to housing numbers and sites there was nothing that realistically could be done on the Neighbourhood Plan until the City came up with a demand figure and then when a viable number is known the locations will be decided. Cllr Martin noted that it was now clear that the Local Plan will always overrule the Neighbourhood Plan.
 Cllr Martin passed round the flooding leaflet which is to be distributed.
 Cllr Martin also read a Planning Decision letter from COYC Planning Department that made it clear they still were not prepared to adopt a positive stance on tackling Dunnington's surface water flooding problem
- 9.3 A discussion took place as to the viability of a Housing survey. Cllr S Kay suggested approaching experts who do this to ensure it is not a wasted exercise. Action the Chairman to speak to people who have more expertise in this area.
- 9.4 Housing allocations and Neighbourhood Plans Cllr A Brooks The Copmanthorpe submission is awaited and once they submit it may provide some useful indications to how the City Council will approach the relationship between Local and Neighbourhood Plans.

10.3 Report Finance and Strategy group – Cllr A Brooks – nothing further to add than that already discussed in the meeting.

11 <u>REVIEWS</u>

- 11.1 Local projects Cllr S Kay Nothing to report, Cllr S Kay said any suggestions would be welcome.
- 11.2 PFA Update Cllr J Farmer The PFA and the Sports Club are doing well. The Sports Club paid a further £12k of the loan and £3k rent. The CCTV cameras have been put up around the actual club. Looking into getting them further afield to include Play Area. A new Secretary and Treasurer have been appointed
- 11.3 Web site Cllr L Turnbull Cllrs L Turnbull and Stuart Kay have not met with Nick Hemingway yet. Liz suggested some quick hits to update the site would be Photos/info about each councillor, information about each Sub-committees plus minutes of their meetings, list of facilities in the village and list of clubs and associations in the village.
- 11.4 In-Bloom Cllr R Freer Most of the work is done for the In Bloom judging this week. A big thank you must be given to York Probation Service as without their help the work would not have been completed to the standard it has reached. Russell Stone arranged for the edge to be done and a further donation is expected. Cllr L Turnbull reported that the front garden winners have been told who has won.

11.5 Environment – Cllr L Turnbull – The Environment group met for the second time on 6 July. An additional purpose was added to the remit, - FOSTER AND SUPPORT THE NATURAL ENVIRONMENT. This will be discussed in more detail at their next meeting in October. One of the group members, David Mayston will have a look at trees on The Green and at Undergate Field. Discussion took place regarding Trees and Cllr J Brooks was asked if she could obtain a copy of the last Tree inspection report as Liz had been advised the next inspection was due in 2016.

A proposal for a wild flower patch in Millennium Gardens was discussed and decided to look at for the future.

The bus stops in Common Road and at the top of Church Street do not have bus stop signs and it was requested that the transport group pick this up.

Cllr A Brooks mentioned the grass cutting and what a special job they are doing.

A complaint regarding a tree outside 15 Intake Lane has been received. It was confirmed that the tree is on DPC land and this will be referred to the Insurers.

- 11.5.1 Kerver Lane Borders and Costcutter advertising Cllr J Errington The issue was raised regarding the Kerver lane borders, some of which are trimed back by the residents and others are not. The residents or the COYC are responsible so the residents should speak to COYC to ascertain what should happen. Costcutter have removed the advertising.
- 11.6 Cemetery Cllr N Ford Cllr S Kay reported that the Cemetery group had met and discussed Finance, the day to day operation, development of phase 2 and the location of the tree on the East side of the cemetery.
 - As a result fees will be increased in line with inflation and the notice board is not fit for purpose and so quotes will be obtained to replace it. Wording will be added to the application forms for the memorials to ensure they are fixed to standard regulations. The group were happy with the flow of income received and reserves are being set aside to deal with the long term maintenance that will be required. It was noted that the hedges within the cemetery are too low to allow privacy for mourners and so these will be allowed to grow.
 - The group intend to meet 3 times a year.
- 11.7 Playpark Cllr J Maggs the litter picking is ongoing but nothing untoward to report and the Park use is high. There is rot on the Dragon Swing and this will be replaced. Fundraiser raised £364 and 50% goes to the Play park. The Chairman S Kay thanked Cllr J Maggs for all his hard work.
