1 FORMALITIES

- 1.2 The Parish Council approved all Apologies and reasons for absence
- 1.3 Previous Meeting Minutes (12/6/17) were approved and signed by the Chairman.
- 1.4 Declaration of Interest None

2 POLICE REPORT

2.1 Sergeant Danny Lynch attended the meeting, after an explanation of how he and his team are dealing with the York area, discussions took place in respect of recent incidents and how the PC would like reporting of incidents that take place. Incidents such as the recent increase in crimes from criminals who live outside the area were discussed. The PC asked for reassurance that Dunnington was not being targeted which Sergeant Lynch did not think was the case. Operation Collaborate will take place in the future and details will be published.

4 MEMORIAL SEAT

4.1 The Parish Council have received a request to install a Memorial in the village in the form of a seat. A discussion took place and it was decided that the cemetery was the best location but that it must be in accordance with the Parish Council's memorial policy. The PC agreed that this could go ahead. Richard Tatham will be asked to speak to the person involved.

5 PARISH COUNCIL ADOPTION AND APPROVAL OF POLICIES/REGISTERS/STRATEGIES

5.1 Adopt Standing Orders, Financial Regulations, Data protection Policy, Risk Register and the Emergency Plan – All were adopted by the PC Cllr Andrew Brooks proposed, Cllr John Harrison seconded.

6 CEMETERY SIGNAGE

6.1 Options for Cemetery signage were discussed and the decision was taken to consult the nearby residents and then make the decision. The quoted prices were agreed by the PC.

7 ALLOTMENTS ON THE GREEN AND MILLENIUM GARDENS

The allotments on the green have been tidied and a request has been made for hire of a skip - PC agreed (£190 + VAT).

The Millennium Gardens also have issues with overhanging trees and the bed at the back. Cllr L Turnbull will check if the tree is in the Conservation area. A quote will be obtained by Cllr Freer to get the work carried out. It was agreed Section 106 money could be used for this purpose.

8 COMMON ROAD TELEPHONE KIOSK

Cllr A Dykes reported that the kiosk has been disconnected and the intention is to sell it to a resident but first it will be discussed with the author of the village design statement to ensure that she will not oppose its removal.

9 LOCAL AND NEIGHBOURHOOD PLANS

- 9.1 Update on the Local Plan Cllr J Brooks reported that a Local Plan working Group was taking place the same night as the PC meeting. The updated Local Plan for Dunnington is the broadly the same as was published 12 months ago. The updated Plan will go to Executive Committee on Thursday and consultation should commence sometime in September. A further discussion took place in respect of the revised plan and implication for the green belt.

The Green – Moles seem to have disappeared

MUGA – the school will reconvene in September and we should ask for a report when they return.

Bins - Cllr J Brooks has emailed Russell Stone

The request for Planning for a Fish and Chip Van was discussed and the PC have many objections which the Chairman will put forward to COYC

The Chairman has been asked to discuss a potential Dunnington Tree Trail with the PC – this was passed to the Environment Group to discuss with Derek Utley

Owlwood Lane Path – This is ongoing

History Board – This will be reviewed and brought back to the PC in September

11.2 PFA Update – Cllr J Farmer reported all going well and the AGM will take place on the following Thursday

11.3 Web site – Cllr A Dykes reported there had once again been over 200 hits and all the Councillors were reminded to let the Clerk know if they would like their own PC email address to be set up.

11.4 In-Bloom – Cllr R Freer reported the judging had taken place and the village looked as good as it ever had. The school had made a wonderful effort and impressed the judges. .The judges awarded the prizes on Judging Day.

Two cheques have been received for donations £80 and £40.

The probation service has cleared some of the overgrown allotments and will be back the following weekends to clear some more.

11.5 Environment – The Chairman reported that costings have been received for the Hassaccar Lane works. The Chairman is investigating ownership of each part of the lane in order that contributions may be requested.

Hassacarr Lease – A meeting has taken place with our solicitors and it is hoped a conclusion can be reached soon.

Urban Buzz which has funded all the wild flower planting, bee houses and spring bulbs has now come to an end. The City of York Council Environment Network Group has circulated information about a source of volunteers from 'York Cares'. Details available from Liz The outcome of the application for tree works on The Greens is still awaited.

- 11.9 Emergency Plan Cllr L Turnbull reported that the Plan will be ready to go on the website in next few days. Emergency box still needs to be arranged.
