6 A1079 LAYBY

The Parish Council stated that if gates are installed at the Scrap box location then these should be the responsibility of the Scrap box. The Parish Council is supportive of Cllr Mark Warters' actions on the layby on the other side of the road and will wait to see what response there is from COYC

The issue of the gates at the layby on the A166 was raised as the owner of the gates has left the site but he is willing to sell the gates to the Parish Council — A discussion took place in respect of this proposal and the Parish Council decided they were happy in principle to purchase them — will be an item on July's Agenda to make a final decision.

7 DUNNINGTON THROUGH THE AGES

Dunnington through the Ages are winding up due to lack of members and have asked the Parish Council to take over responsibility for the archive. There is £1070 in their bank account which they would transfer to the Parish Council. There is only one expense, £100 per annum for storage of documents. A discussion took place and the feeling was that the Parish Council would be happy in principle but assurances would be needed in the form of a letter that the cost of storage would not increase for at least five years.

11 REVIEWS

11.1 Local projects – Cllr S Kay reported as follows

- Hassacarr awaiting response from one remaining landowner. Only one has given a
 positive response to date. The four owners/ users of the lane have now been
 identified and are willing to contribute. The Parish Council is happy to contribute a
 proportionate amount. Simpsons to be approached as they own part of the lane.
 Need to now look at how to move forward and what the contributions should be.
- Allotment fencing still work in progress.

- Street lighting on York Street

 – after discussion the Parish Council agreed the

 Chairman will advise COYC that the Parish Council wishes to stay involved in the

 process.
- Parking Bay on York Street Cllr J Brooks advised that if it is to go ahead it would most likely take all the remaining Ward money so no other projects could be considered. The Parish Council agreed in principle it should go ahead if the costs are reasonable.
- 11.2 PFA Update Cllr J Farmer sent a report. A treasurer has now been found but they have vacancies for Trustees. The chairman will attend the AGM on 19th July 2018.
- 11.3 Web site Cllr A Dykes reported that a meeting had been held earlier to review the website. Cllr Dykes gave an overview of the changes to be made.
- 11.4 In-Bloom Cllr R Freer has been round the village and had some criticism of some of the grass cutting. The Chairman has written to the grass cutting provider. Baskets are ready to be put up in York Street. Some work has been carried out on the allotments but a number were not being looked after.
- 11.5 Environment Cllr L Turnbull reported as follows
 - A tree trail is being worked on
 - Cllr J Brooks will speak to the MP for the area re grass verges
 - Three of the new trees planted do not seem to be doing well the supplier has been contacted and this will be monitored
 - In Autumn the Oak in the Millennium gardens will be looked at as it may need to be replaced
 - Wild chicory has been planted in various locations in the village
 - It has been reported that the footpaths on the green are being used as cycle paths
