#### 1 POLICE REPORT

The Chairman Cllr S Kay mentioned that PCSO Laura Harper has advised she is no longer to the Parish PCSO. Cllr Kay has written twice to North Yorkshire Police and asked them to attend a Parish Council meeting to discuss this but as yet a reply has not been received.

### 3 PUBLIC PARTICIPATION

Any member of the parish may speak for up to 5 minutes on any matter on the Agenda with the session lasting no more than 20 minutes – No public participation.

#### 4 PROPOSAL FOR FRIENDSHIP BENCH

The Chairman had been asked by the Fayre Committee to make it clear to all Parish councillors that the Friendship bench is not a memorial and thus should not be considered as such.

The Chairman updated the Councillors on four things that had happened since our last discussion

- A Meeting with the Friends of the Play Park had taken place their comment on the Friendship Bench was that they are neither for nor against it.
- Comments from the Play Park insurers had been circulated if the bench was to be placed in the Play Park it must be sited well away from the apparatus before they would consider insuring it.
- The Rospa report had been received and circulated the chairman read the report details and recommendations
- Cllr D Martin had written a paper which had been circulated

A lengthy discussion then took place focusing solely on should the proposed stone bench be placed in the Play Park. All councillors contributed to the discussion.

It is clear a stone bench cannot be considered a piece of play equipment and is introducing something into the Play Park that does not need to be there. The proposal is therefore needlessly adding an additional risk which must be assessed carefully. The overwhelming feeling was, given our overarching responsibility to ensure the safety of the children that the Play Park was not an appropriate place to put a stone bench.

Following the discussion a proposal was put to the Council 'Should the Friendship bench be placed in the Play Park?'

In favour – None

Against – Unanimous

Cllr J Farmer suggested that SK and JF should visit Oscar's parents to explain the decision and SK agreed this would be the right thing to do. JF agreed to arrange a meeting with Oscar's parents.

# 6 LOCAL AND NEIGHBOURHOOD PLANS

**6.1** Update on the Local Plan – Cllr J Brooks

Dunnington had been invited to send two PC councillors to the first meeting of the Alliance Group. The PC agreed the chairman would attend to follow the discussion and to contribute to the debate in the context of how the Alliance might serve Dunnington's interests and to report back to the next PC for further consideration. Members agreed that Dunnington PC resents being publically referred to by others as leading the way in opposition to gypsies in Alliance communications. Members reiterated the PC's long standing position that there was no blanket opposition to gypsies but rather to a very clumsy and inappropriate choice of site.

6.2 Update on the DPC Neighbourhood Plan – Cllr D Martin

Cllr D Martin advised that the Chairman has placed the Neighbourhood Plan Contract with one of the two Consultants that were shortlisted. This consultant is based in Newcastle and he was involved in writing the first Neighbourhood Plan for Copmanthorpe.

Cllr D Martin stressed the importance that this is done correctly as there is a possibility that 2.25 billion will be spent in York alone so to deal with any developers who will jump on this opportunity the Neighbourhood Plan must be in place and the detail must be of the highest standard.

6.3 Report Finance and Strategy Group – Cllr A Brooks

Cllr A Brooks requested views on the housing as there are several sites open for development and to give zero housing as an option will not help. Suggestions should be given on type and numbers of housing and possible sites.
