1 FORMALITIES

- 1.1 Apologies All Councillors attended
- 1.2 Parish Council approval of Apologies and reasons for absence None required
- 1.3 Previous Meeting Minutes (9/10/17) were approved by the PC and signed and dated by the Chairman.
- 1.4 Declaration of Interest N Ford and A Dykes item 13.1

2 POLICE REPORT

2.1 Police Report – The report sent by North Yorkshire police was discussed and it was commented that there were more than usual number of crimes reported in the village but there was limited detail once again. It was noted that there will be dedicated patrols in the village which the Parish Council appreciate and it was decided the Clerk will send a letter to express thanks that these patrols will take place.

3 PUBLIC PARTICIPATION

Two members of the public attended to make objections to item 14.4.

The Council brought forward the discussion in respect of 14.4 and after a discussion it was decided that the Parish Council would object on a number of planning grounds to the development.

York City Councillor Mark Warters also spoke and mentioned that a number of residents have invited the acting Chief Executive of COYC to look at the development at 25 Garden Flats Lane. She has agreed to the meeting. The representative from the Parish Council will be Cllr A Brooks.

- 4 LOCAL PLAN CONSULTATION The Chairman reported that a meeting had been held for residents in the Tower Room. Around 20 people attended. The Parish Council's comments on the Local Plan have been submitted. It was requested by a resident that any future meetings on the Local Plan should be advertised more prominently.
- 5 ALLOTMENTS FENCING A quote has been received for a new fence but after discussion it was decided to obtain further quotes and to include costs for a phased approach to fence the whole area. The clerk will check how many quotes should be obtained.
- 6 HASSACAR Yorkshire Water have now signed the lease agreement. The Land must now be registered. The Clerk will look into registering it with the Land Registry.

- YORK STREET ELECTRICAL WORK The Chairman Stuart Kay met with National Power in respect of the replacement of the substation on York Street. He requested that it should be sited as far back from the road as possible. National Power will also install underground cabling along York Street to its junction with Common Road. It is hoped the work will be carried out March/April 2018. This should make the electrical supply to the village more resilient.
- STREET LIGHTING At some date in the future the electricity poles will be taken down in York Street and as the street lights are attached to the poles these will require replacement. The Chairman asked if it was felt that we should be pressing for more lights along York Street and asked for suggestions of the types of lights we would like to see. It was likely that anything other than standard replacements would have to be paid for out of Parish or Ward funds. A discussion took place on PC involvement if any and the decision was made to consider further and discuss further at the next meeting.
- **9 DUNNINGTON PARISH TRAIL** Cllr A Dykes had quotes for two boards and design and asked if the Parish Council wished to pursue them given the costs. A discussion took place and the meeting felt that Cllr Dykes should look into other possible funding sources and come back to the meeting when he had further information .

11.3 Report Finance and Strategy group – Cllr A Brooks had nothing new to report

12 REVIEWS

- 12.1 Local projects Cllr S Kay reported on the following:
 - Land at Intake Lane which the PC is considering selling We are awaiting the report
 on the valuation from the Surveyors which the prospective buyer has agreed to pay
 for
 - Cllr A Dykes is looking to try and ascertain the ownership of Hassacarr Lane
 - A working group has been set up to fully document the ownership of all PC Land (Cllrs A Dykes and L Turnbull)
 - LINKS The Chairman has spoken to the other groups active in this area and she is hopeful that the previous issues can now be resolved.
 - The allotments are beginning to have increased running costs and so it is proposed that the annual fee is raised and a bond requested for any new applicants. Any such increase will require a year's notice – this will be discussed further at the next meeting
- 12.2 PFA Update Cllr J Farmer reported that the PFA is under some pressure with all the demands around risk assessment/data protection/fire risk with so few volunteers. However, sporting sections doing well although they also do not have large committees now. There will be a raffle for the Play Park at the Xmas Party on the 22nd December. There was a further discussion on the lack of Play Park volunteers and the consequences if none were forthcoming.
- 12.3 Web site Cllr A Dykes reported that the site visits remain constant. The mobile internet access problem is to be raised again with the website provider
- 12.4 In-Bloom Cllr R Freer reported that the daffodils have been planted on the village green.

 Xmas Tree have been ordered and one donation of £25 has been given already towards the cost of the trees.

- 12.5 Environment Cllr L Turnbull reported as follows
 - No smoking sign has been purchased and is to be put up in the bus stop
 - A smoking ashtray should be considered for outside the bus stop
 - The new trees for the green will be planted on 29th November
 - The environment group will meet again in January 2018
 - Cllr Turnbull has received a complaint about the hedge in Eastfield Lane. A discussion took place as to who owns the hedge. Cllr Brooks will investigate whose responsibility it is.
- 12.6 Cemetery Cllr J Harrison reported that planning on the next phase had begun.
- 12.7 Playpark Cllr J Maggs reported that the ROSPA inspection was carried out with only a small amount of rot found in one of the supports. This will be repaired or replaced.
- 12.8 Transport Cllr J Maggs had nothing new to report but Cllr N Ford brought to the attention of the PC that a petrol tanker that has been seen passing through the village. It was suggested that if the petrol tanker was seen again it should be reported to the company involved.
- 12.9 Emergency Plan Cllr L Black had nothing new to report. A meeting will be held in January 2018.
- 12.10 Ward Committee Cllr J Brooks reported there are still funds available. Still no news on the Highways Layby costing. Cllr J Brooks thought there may be something in previous minutes in respect of the Layby.
- 12.11 This Is Dunnington Cllr A Dykes reported that TID have now got the feedback to the survey which will be delivered to the PC at a future meeting.
- 12.12 Scouts and Guides Cllr A Dykes reported that three Parish Councillors met with the Scout and Guide Group. The way forward was agreed in principle. A risk and electrical assessments are to be carried out. The removal of asbestos was discussed and it was decided in principle that the PC are happy to pay for it. However before a final decision is taken the PC asked to see the results of the asbestos report at the Sports Club.
