7.3 Report Finance and Strategy group – Nothing to report but a meeting should be arranged to recommend a Budget for the financial year 2018-19.

8 REVIEWS

- 8.1 Local projects Cllr S Kay reported as follows
 - The resident who approached the PC about buying some PC Land has requested a quotation for the cost of a valuation and legal fees.
 - The Lease for Hassaccar has been signed by Cllrs S Kay and J Brooks
 - The Land Registry information obtained still does not give the detail for the whole area this will need to be revisited
 - MUGA no further communication since the school were informed the PC would give the final £3k
 - OCAY are to approach older citizens in the village to their needs which will mean two separate organisations are involved (Also LINKS). The PC cannot get involved unless the two groups work together.
- 8.2 PFA Update Cllr J Farmer sent a report that all is going well. A Minute Secretary is in place but that a Treasurer and Chairman are still required.
- 8.3 Web site Cllr A Dykes sent a report of the site visits for September (307).
- 8.4 In-Bloom Cllr R Freer sent congratulations of the achievement in the Yorkshire in Bloom Competition. In Bloom have decided that Dunnington will not enter in 2018 but this will be reviewed annually. Two estimates have been obtained for work at the Millennium Gardens and the Allotments.
- 8.5 Environment Cllr L Turnbull reported
 - A number of trees have now been pruned and 3 removed. In addition a further 3 diseased trees belonging to City of York Council have been removed. Eight new blossom/fruit trees will be planted by the Parish Council.
 - Pollinator project cleared most of the beds, some re-seeding will be done in the spring
 - There has been some vandalism at Hassaccar
 - Hagg Wood volunteers have recently been clearing silver birches around the oak saplings in the Millennium Area
 - The Environment group have discussed the plastic items that residents are putting in the Recycling boxes as these are not as specified by the Council
 - The Environment group would like to have a say on planning issues that impact on trees. This was agreed.

- 8.6 Cemetery Cllr J Harrison reported that the Cemetery Group had met and discussed the following
 - To use the bottom row of burial plots as Ashes if the Ashes plots are all taken. This was agreed
 - Fees these will increase in line with RPI and rounded to the nearest £5. This was proposed by Cllr S Kay and seconded by Cllr L Turnbull. This was agreed.
 - Cllr J Harrison reminded the PC that money must be retained for the future when maintenance will be required but income will not be available
 - The next phase preparation is to begin with flailing which is to be arranged by Cllr N Ford.
 - Publicity was discussed and it was thought there may be something begun previously in the archive that could be used the Clerk will investigate.
 - The Tree policy was discussed in respect of access to the Cemetery.
 - It was agreed in principle that primarily the cemetery is for the residents of Dunnington so any enquiries from outside should be referred by the Clerk to the Cemetery Group first.
 - A site meeting for all parish councillors is to be arranged.
- 8.7 Playpark Nothing new to report: the summer has passed reasonably well with less antisocial behaviour.
- 8.8 Transport Cllr J Maggs nothing new to report
- 8.9 Emergency Plan Cllr L Black reported there will be a meeting in November with COYC.
- 8.10 Ward Committee Cllr J Brooks was not available but Cllr Mark Warters reminded the PC that Highways funding was available
- 8.11 This Is Dunnington Cllr A Dykes sent a report to say the PC continues to use the TID Facebook page in addition to the PC website to publicise important matters such as the Common Road Telephone Box which received plenty of Feedback and the Local Plan Drop in session.
- 8.12 Scouts and Guides Cllr A Dykes sent a report to say the scheduled meeting did not take place and has been re-arranged for 6th November 2017
