Minutes of the Ordinary meeting of Dunnington Parish Council held on the 8th January 2024 at 7.30pm in the Tower Room, St Nicholas Church, Church Street, Dunnington

The meeting started at 7.31pm

01/24/01 FORMALITIES

a. To receive apologies for absence.

Apologies were received from Cllr Rees-Gay

Cllr Kay advised that he would arrive late.

b. To approve the Minutes of the Parish Council meeting held on the 11th December 2023.

It was <u>RESOLVED</u> to approve the minutes of the Ordinary Parish Council meeting held on the 11th December 2023.

c. To receive any declarations of interest and approve any dispensation requests.

(It is a requirement in law, Localism Act (2011, s31) that Council members declare any Disclosable Pecuniary Interest)

Cllr Thompson declared an interest in item 9.

01/24/02 EXCLUSION OF PRESS AND PUBLIC

It was <u>RESOLVED</u> to exclude the press and public from item 10a.

01/24/03 PUBLIC PARTICIPATION

Any member of the Parish may speak for up to 5 minutes on any matter on the agenda with the session lasting no more than 20 minutes.

A resident spoke about Hagg Wood. The resident asked that the Parish Council consider supporting any Forestry England proposals to improve public access to Hagg Wood. They stated that a lot of Dunnington residents use and access Hagg Wood. They raised concerns that there is no emergency access into the woods.

01/24/04 UNAUTHORISED ENCAMPMENT – A166

To receive an update from Jane Mowat, Head of Community Safety and Cllr Pavlovic, City of York Council

Jane Mowat sent apologies but advised that she will provide a further update following a meeting with Neil Ferris. The Parish Council received no response from Cllr Pavlovic. It was RESOLVED to invite Jane Mowat, Cllr Pavlovic and Neil Ferris to the February Parish

Council meeting referring to the Parish Charter. The Parish Clerk to ask how many pitches at currently available at James Street, Clifton Moor and Osbaldwick sites.

01/24/05 FINANCES 2024/25

a. To confirm the amended budget 2024/25

It was <u>RESOLVED</u> to approve the budget for 2024/25

b. To consider and approve the precept amount for 2024/25 (to include the Chairman signing the request)

It was <u>RESOLVED</u> to approve the 2024/25 precept request as £42,608, an increase of £663 on 2023/24 and the paperwork was signed.

01/24/06 POLICY

a. To approve the biodiversity policy.

It was <u>RESOLVED</u> to approve the biodiversity policy with the addition of the land off intake Lane.

It was noted that the policy requires a plan in place behind the policy and a possible working group. It was <u>RESOLVED</u> that a working group will be considered at the Annual Parish Council Meeting in May.

01/24/07 COMMUNITY

a. To consider GIGs request to produce the tree trail leaflet in print.

Following a discussion that included concerns around the environmental impact of printed copies, It was <u>RESOLVED</u> to print a library copy and produce a QR code to display around the village to access the leaflet.

01/24/08 COMMITTEES/GROUPS

a. To consider a road narrowing proposal from the Highways group.

Cllr Maggs confirmed that the Highways group are looking at possible road narrowing options on Common Road. He also mentioned that the Highways group are currently looking at the pothole issues within the village and the VAS sign on the humpback bridge that is not working correctly.

b. To receive an update from the Neighbourhood Plan Group

Cllr Dykes confirmed that traffic management will be included in the village design code and that the consultants will be conducting a village walkaround o look at any potential issues.

c. To receive and consider an update from the Village Show working group.

Cllr Shaw confirmed that there was no significant update due to the Christmas period. The show has managed to obtain two volunteers.

A discussion took place about a possible entry charge and the village organisations that could benefit from the monies raised.

Cllr Kay arrived at the meeting.

a. To consider if any response is required to the Forestry England proposals for Hagg Wood. A discussion took place. During the discussion, various points were raised, including:

- Identification of an alternative path not shown on the Forestry England consultation.
- Expression of opinions that Forestry England's proposed plans contradicted themselves.
- Recognition that participating in the consultation process will not impact any alterations to access.
- Some Councillors emphasised the significance of the facility to Dunnington residents. Questions about the suitability of conducting a resident consultation on the documentation was discussed. It was clarified that the response deadline precluded a resident consultation, but Forestry England intends to carry out a public consultation in the future.

It was <u>RESOLVED</u> to approve a draft response to the consultation, with the addition of a suggestion that emergency access is considered.
