# 12 REVIEWS

# 12.1 Local projects

A Parishioner has requested Parish Council support for an additional bus stop on Hull Road. After discussion it was decided that as there was already a bus stop in the area the Parish Council would not support this request.

Hassaccar Lane Surface—We are still awaiting confirmation of ownership from the Land Registry. Discussion took place on options.

A request has been received to buy a small section of Parish Land on Intake Lane. After discussion it was decided that any sale would need to be at arm's length. All Parish Council's legal costs would have to be paid by the purchaser and an independent valuation would be required. However it was agreed that the Parish Council may be prepared to sell it. Hassaccar agreement is in the last stages

- 12.2 PFA Update Cllr J Farmer sent a report to say that sporting section running well and a Minute secretary had been found.
- 12.3 Web site Cllr A Dykes reported on the number of visits to the website and it was decided an annual review will take place at the end of the year.

12.4 In-Bloom – Cllr R Freer reported that the In Bloom award presentation will take place on Tuesday 12<sup>th</sup> September. The In Bloom team were given the good wishes of the meeting for the presentation. There was disappointment with some York Street residents who have baskets provided for free but they had not been watered and the plants have died

The Probation services have done a good job at the allotments and thanks to them. The fencing at the allotments is being progressed.

12.5 Environment – Cllr L Turnbull reported that the tree work on the Green and in Julia's garden had been completed but there was some work that was not done as agreed so the contractor will be called back and they will be asked to do some additional work which will not increase the price. The resulting spare wood has now all gone and new trees will be planted. We are expecting contributions to pay for purchasing the new trees. The wildflower beds will be cut back. Common Road Bus stop trees were overhanging. Thanks to Stuart Jacques for his work cutting these back.

Bus stop in York Street requires no smoking signs – the Clerk is looking in to this.

Cllr Turnbull received a letter commenting on the Public Rights of Way.

- 12.6 Cemetery There was nothing to report but a meeting of the Cemetery Group will be held shortly
- 12.7 Playpark Cllr J Maggs reported that another summer season was drawing to a close with the replacement of two sets of shackles on the typhoon. They have been replaced free of charge again by Playscheme. There has still been no progress on finding a new Chairman and secretary. There are currently not enough Volunteers to keep the Playpark running long term.

The CCTV has made a huge difference to the number of incidents reported.

- 12.8 Transport Cllr J Maggs reported that black boxes have appeared on Common Road so work is happening.
- 12.9 Emergency Plan Cllr L Turnbull reported that this is now complete, boxes are in place and only need to organise a workshop with COYC.
- 12.10 Ward Committee Cllr J Brooks reported that we are still awaiting news on York Street layby.
- 12.11 This Is Dunnington Cllr A Dykes reported that apologies were received for not sending the results of their recent survey. Cllr Dykes will ask if there is anything more the PC can do to help.
